





### Project Remediate – a case study






#### **Achieved outcomes:**

- All products in pattern book verified as compliant with BCA and Australian Standards
- All warranties enforceable in Australia
- Exposes Australian industry DfMA weakness

# Project Intervene – evidencing long term systemic failures










Statistics on defects found during inspections for Project Intervene
